Residents look back at Guam's unforgettable typhoons

PAMELA, Paka and Pongsona are some of the more memorable names that come to mind for Mary Atoigue when she thinks back to typhoons of the past.

Atoigue said she was a teenager when Typhoon Pamela ripped through Guam in 1976. Now 52 years old, the Yigo resident said what she remembered most about Pamela was the calm before damaging weather hit the island.

"Just like now, it's calm," 76-year-old Felicita Naputi said of yesterday's weather.

According to a 1976 report from the Joint Typhoon Warning Center, Typhoon Pamela was responsible for the death of 10 people in Chuuk state and one dead on Guam. Pamela was the fourth typhoon to develop that year, forming on May 13, the JTWC report states. Pamela hit Guam as a super typhoon with wind gusts measuring up to 150 mph and 24 inches of rain recorded in a 24-hour period. Pamela's large eye took three hours to pass over Guam, the JTWC report states. Pamela was 28 mph weaker than Typhoon Karen, which tore across Guam in November 1962 with wind speeds of 178 mph, according to the JTWC report.

Atoigue recalled times when her family had to brave the storm while wind gusted and rain pelted the island. She said during Pamela her uncle and brother were out in the storm trying to secure and board up a window and during Paka her husband had to rescue her sister-in-law and her children next door.

"He had to get my sister-in-law

out because where we stay, there are barracks in the back and a lot of tin and structures kept flying and it hit a window," Atoigue said.

Typhoon Paka hit Guam in December 1997 and left two injured with no fatalities, according to the National Oceanic and Atmospheric Administration's National Climatic Data Center.

Paka hit Guam on the early afternoon of Dec. 16 and destructive winds continued through the next morning. Winds topped 115 mph with gusts of 117 mph and were strong enough to damage wind recording instruments. Power all over the island was shut down and Paka caused about \$16 million worth of damage to the main electrical system, according to the National Climatic Data Center. About \$500 million worth of damage occurred on Guam because of Paka, the NCDC report states.

Dorothy "Dolly" Sanders of Piti said she had just arrived on Guam before Typhoon Pongsona hit the island in December 2002. Pongsona was Guam's last major typhoon, injuring 300

people, destroying 400 homes in Yigo alone, damaging 72 of the island's 110 water wells and wrecking numerous facilities, from hotel lobbies, to village churches and causing a major fire at the Mobil tank farm adjacent to the commercial port at Cabras Island, according to NCDC. Pongsona caused an estimated \$72 million worth of damage.

Sanders said she was living in Hagåtia at the time of the storm and her apartment complex was spared from major damage because of a wall behind the building blocking the wind. However, other parts of the island were devastated, Sanders said.

Albert Toves, 65, of Tamuning said he remembers Pongsona as one of the worst typhoons to hit Guam while he was on island, aside from Typhoon Karen. Toves has worked with Guam Homeland Security for 12 years and was employed with GHS when Pongsona blew through Guam.

Toves said residents should always be concerned with how the storm is tracking and they should be prepared whether the storm hits Guam or not. "The worst one that I experienced that hit us here on Guam is Pongsona due to the fact that Typhoon Chata'an had just battered Guam and loosened everything up," Toves said. "Pongsona just came and swept it up after that."

During his assessments with GHS, Toves said he was very sorry to see a lot of people who experienced major loss.

Atoigue said of all the typhoons she's lived through, Pongsona was the worst. Atoigue was one of the 3,000 residents who were displaced after Pongsona.

"(During Pongsona) you can hear a lot of stuff, the wind - you can really hear it, the howling of the wind," Atoigue said.

Afterward the weather was

sweltering and because of the power and water outages, clothes had to be hand-washed, Atoigue recalled. "We had to make boards to hand-wash (clothes)."

"We haven't had this in a while," Sanders said of the approaching Typhoon Dolphin. "But this one reminds us of other typhoons that have hit Guam."

Sanders, who is a recreational leader at the Dededo Senior Citizen Center, said she received a phone call from one of the center's members and she said she thinks Typhoon Dolphin might have a major impact on Guam. "She said, 'You know, I don't want to say it, but it's reminding me of the past storms, and that's the calm before the storm,'" Sanders said.

Sanders said senior citizens should not only prepare to have food, water and shelter, but they should take care that they have their medicines with them, too.

Above all, Sanders said for her the best preparation is to pray. "We never know. Like I said, we always just continue. I think above everything - it doesn't take much - open your eyes and give God glory and praise," Sanders said.

GHURA has determined that the project will have no significant impact on the human environment.
