Police arrest man who allegedly pushed meth in daughter's presence

A MAN who allegedly sold methamphetamine in the presence of his daughter was arrested by federal agents on Thursday.

Federal agents with the U.S. Drug Enforcement Agency received a tip from a confidential informant identified by the DEA as its "source of information" on July 30 about the availability of methamphetamine, the drug commonly known as "ice." from the desendant's home in Tumon Heights.

In the succeeding week, DEA arranged with the source to purchase a certain amount of methamphetamine. The SOI initially purchased a gram of the suspected methamphetamine from the suspect at

his residence. The suspected drug was tested by the federal agents: the field test resulted in a presumptive positive for methamphetamine.

An agreement was made shortly thereafter by the source and the defendant to purchase an additional four grams of methamphetamine. According to court documents, the suspect agreed to charge the source \$400, which the source was to pick up from the residence.

Armed with the positive test and the agreement, DLA agents obtained a federal search warrant last Wednesday and conducted surveillance on the resident at his residence for the next day and a half. On Thursday, the suspect, Timothy C. Advincula, was pulled over by agents as he attempted to leave his home with his minor daughter.

Advincula was advised of the search warrant for his residence. As well, the agents searched the vehicle which Advincula and his daughter were in. The defendant reportedly admitted that a bag in the vehicle was his. Agents discovered just under five grams of suspected methamphetamine. A field test resulted in a presumptive positive for methamphetamine. Advincula also had \$3,590 in cash in the bag.

Advincula, 38, of Tumon Heights, was charged on Friday in the U.S. District Court of Guam with distribution of methamphetamine and possession with intent to distribute methamphetamine. He is in federal custody awaiting a preliminary hearing scheduled for Aug. 21. Ife is represented by attorney David Lujan Jr.

Drunk driver flees scene of head-on

TEXTER Romot, 22, admitted to police he had consumed alcohol and fell asleep behind the wheel of a silver Nissan Sentra. Romot was startled awake when his car collided head-on with another vehicle. Romot then fled the scene of the accident.

On Aug. 5 at around 6 a.m., an officer from the Guam Police Department responded to a two-vehicle accident along a curved highway portion of Route 4 in Umatac, according to the magistrate's report.

When the officer arrived, he found a silver Toyota Tacoma with damage to its front but did not see another damaged vehicle at that location, the report said.

The officer spoke with the Tacoma's operator and owner.

"The victim stated that earlier that morning, he was driving northbound on Route 4 which curved towards the right. The victim said another vehicle, a silver Nissan Sentra was simultaneously traveling southbound on Route 4 toward the victim's silver Toyota Tacoma," it said in the report.

The victim indicated that the Sentra entered the victim's driving lane and struck the Tacoma head on. The victim reported that after the collision, the Sentra drove away, south-bound on Route 4.

The victim complained of pain and was transported to Guam Memorial Hospital.

Later that morning, the officer spoke with a witness who told the officer she was a passenger of the Sentra. The witness also told police Romot was the operator of that car.

Ataround 7: 10 a.m. on that morning, an officer met with Romot at the Umatac mayor's office. When speaking with Romot, the officer reportedly smelled an odor of an intoxicating beverage coming from Romot's mouth.

Romot told the officer that on that morning, he drove the Sentra to a beach, parked the car and then drank a bottle of whiskey and an unknown number of cans of Bud Light.

Romot reportedly told the officer he then drove the Sentra and fell asleep while driving. He was awakened "due to the impact of the crash with the silver Toyota Tacoma."

Patient transferred from GRMC to GMH dies

A 69-YFAR-OLD patient being treated at Guam Memorial Hospital has died. Variety learned.

The patient was treated at GMH after he had first sought treatment at Guam Regional Medical City.

GMH spokeswoman June Perez confirmed to Variety the 68-year old man transferred from GRMC died on Aug. 6.

The patient arrived at GRMC on Aug. 3 but was told the new hospital was not yet ready

to provide the treatment he needed.

The man "was immediately provided a medical screening exam by one of our physicians," said Dr. Felix Cabrera, associate chief medical officer at GRMC. "The evaluation found that the person needed emergency care which is not yet available at GRMC. Nonetheless, initial supportive care was provided to the patient."

Cabrera said the patient was placed in an ambulance and

transported to GMII, where the care that was needed could be provided.

The Variety was contacted by a source at GMH who noted that the man was uninsured. Cabrera said insurance was not a factor.

"The patient was not turned away and the patient's ability to pay was never a factor," he said. GRMC expects to activate emergency services later this month. according to Cabrera.

Manning could face solitary confinement at military prison

NEW YORK (Reuters) - Chel- Leavenworth, Kansas. sea Manning, a soldier imprisoned for leaking classified U.S. information to pro-transparency site Wikil eaks, could face solitary confinement on charges she violated prison rules by having prohibited reading material, her attorney said on Wednesday.

Manning was convicted in 2013 of providing more than 700.000 documents. videos, diplomatic cables and battlefield accounts to WikiLeaks, in the biggest breach of classified materials in U.S. history.

The former intelligence analyst, who was born a man but identifies as a woman, is serving a 35-year sentence at an all-male military prison at I ort

Manning has been charged with a number of disciplinar infractions and will attend : hearing before a three-persor discipline adjustment board or Aug. 18 at the prison, attorney Nancy Hollander said.

The alleged disciplinary infractions on July 2 and July 5 included attempted disrespect the possession of prohibited books and magazines while under administrative segrega tion, medicine misuse pertaining to expired toothpaste and disor derly conduct for pushing food onto the floor, Hollander said.

The maximum penalty she faces is indefinite solitary confinement.

Los Angeles to pay \$15M to teen paralyzed by police

LOS ANGELES (Reuters) - The city of Los Angeles on Wednesday agreed to pay \$15 million dollars to the family of a teenager paralyzed in 2010 when he was shot by a police officer who mistook a pellet gun the youth was holding for a real firearm. Rohayent Gomez Eriza was 13 when he was struck by a single bullet while playing near his home with two friends, according to court documents. His family filed a lawsuit in 2011, saying the teen was "subjected to excessive force" by police officer Victor Abarca in the form of a gunshot that left the boy with "serious and permanent physical and psychological injuries."

(Reuters) - 18-year-old Michael Brown on The St. Louis suburb of Ferguson, Missouri, the site of a year of occasionally violent protests over the police killing of an unarmed black teen, will remain under a state of emergency for at least another night, county officials said on Wednesday.

The state of emergency, which gives county police oversight of security in the city of 21,000 people, was declared following a shooting incident at a protest Sunday night to mark the oneyear anniversary of the death of Aug. 9, 2014. The decision came after two nights of relatively peaceful protests, with the St. Louis Country police reporting no arrests or reports of injuries during a small demonstration by several dozen people Tuesday night into Wednesday morning.

"I am pleased to report our law enforcement officers have established order while preventing further acts of violence in Ferguson." said County Executive Steve Stenger, in a statement.

I. CALL TO ORDER:

This meeting was called to order by the Chairman, Chief Justice Robert J. Torres, Jr. at 12:45 p.m.

II. ROLL CALL:

III. PROOF OF DUE NOTICE OF MEETING:

"Notice of Public Meeting" were published in Marianas Variety on Tuesday, July 14, 2015 and Wednesday, July 22, 2015.

IV. <u>DETERMINATION OF QUORUM:</u>

With the presence of three (3) board members, a quorum was determined for this meeting.

V. <u>APPROVAL OF MINUTES:</u> Minutes of the regular board meeting held on Tuesday, June 23, 2015 were adopted and approved, subject to corrections. Moved by Vice-Chair, PJ Lamorena; Seconded by Trustee, Attorney Cruz.

VI. OLD BUSINESS:

A. Financial Status Updates (PDSC): Chief Fiscal Officer Michael Moreno reported that PDSC is at 85% of its scheduled allotment releases as of the end of May, 2015. Communications were ongoing with DOA. (APD) Quarterly Allotment Releases is at 77% as of the end of June, 2015. Last Quarter allotments are still pending the Memorandum of Understanding from the Judiciary, with amendments. The PDSC Administrative Director has been in contact with Mr. Joshua Tenorio of the Judiciary to follow-up on the MOU.

- **B.** Domestic Violence Program Update: Chief Fiscal Officer Michael Moreno reported that we are operating under the STOP 2014 Grant in the amount of \$46,211.00. This amount should be sufficient for the next eighteen (18) pay-periods of operations.
- C. Alternate Public Defender Update: Managing Attorney Annie Gayle reported on the Strategic Planning initiatives with Dr. Brenda J. Wagenknecht-Ivey of Praxis Consulting Co. This effort should guide the PDSC/APD, the AG, and the Judiciary for the next three-four years in accomplishing our individual as well as collective goals and objectives to better serve the Public.
- D. Executive Director –CWA Pay Grade Assignment: The Board Chair stated that the Executive Director position is an unclassified position. Personnel Specialist Bernadette Lizama reported that three proposed executive pay plans were presented for the Boards' consideration in deciding which pay plan to adopt for the Executive Director of PDSC. The Chair stated that the Board will take these proposed pay plans (attached) into consideration for the next meeting. The Executive Director's position is unique because of the caseload that he carries. A managing attorney pay plan may be another option to consider for the PDSC executive director. This agenda item is continued at the Board of Trustees meeting in August.
- **E. PDSC Executive Director Performance Evaluation:** Trustee, Attorney Donna M. Cruz, and Trustee, Attorney Jehan'ad G. Martinez will continue this effort. Other factors regarding the evaluation process were emailed by the Board Chair to the other Trustees. This agenda item is continued at the Board of Trustees meeting in August.
- F. Amendment/Adoption of PDSC Personnel Rules and Regulations: Discussion centered around the adoption of the PDSC Personnel Rules and Regulations by the Board of Trustees of the PDSC. The present rules and regulations were originally adopted by Judicial Council on June 11, 1985, prior to the passage of the Public Defender Service Corporation Act in 1975. A question brought up was whether the PDSC Board of Trustees can sit as an appeals board to hear grievances/appeals from employees of the Public Defender Service Corporation, or to the Civil Service Commission. A motion offered by the Vice-Chair, PJ Lamorena to adopt the PDSC Personnel Rules and Regulations, on an interim basis, was not seconded; thus the motion was not voted on. Another option discussed was the adoption of the PDSC Personnel Rules and Regulations through the Miscellaneous Provisions of the Fiscal Year 2016 Budget by the Guam Legislature. The Executive Director was requested to draft an internal opinion as an overview regarding this question.

VII. <u>NEW BUSINESS</u>

- **A.** Resolution No. PDSC 20-15: relative to the use of APD Lapsed Funds in the amount of \$3,950.10 to reimburse the Public Defender Service Corporation for the Alternate Public Defender's proportional share of the Strategic Planning fees of Praxis Consulting Co. Moved by Vice-Chair, PJ Lamorena; Seconded by Trustee, Attorney Cruz; Motion was unanimously approved.
- **B.** Resolution No. PDSC 21-15: relative to the use of Public Defender Service Corporation Lapsed Funds in the amount of \$26,765.12 to purchase Rotary Filing Cabinets. Moved by Vice-Chair, PJ Lamorena; Seconded by Trustee, Attorney Cruz; Motion was unanimously approved.
- C. Funding of Civil Public Defender: Executive Director, Eric Miller, initiated discussion regarding the formation or re-establishment of a civil division of the Public Defender Service Corporation. This effort would be initiated with the submission of the Public Defender Service Corporation's Fiscal Year 2017 Budget Request to the Guam Legislature. Another model of the Civil Division of the Public Defender Service Corporation could include an Appellate Division.

The Board of Trustees agreed with these suggestions since a Civil Division of the Public Defender Service Corporation was part of the mandate at the creation of the Agency, but that subsequent funding was eliminated for this Division.

- VIII. <u>PUBLIC DISCUSSION:</u> Executive Director, Eric Miller, initiated a discussion regarding the celebration of the Fortieth (40th) anniversary of PL13-051 known as the Public Defender Service Corporation Act of 1975. Discussion centered regarding guests, prospective dates and projected cost. A committee in house is formed to work out plans and a request will be submitted to the Board of Trustees at the August 18, 2015 meeting to fund the celebration expenses.
- **IX.** <u>ADJOURNMENT AND NEXT MEETING DATE:</u> The next meeting will take place on Tuesday, August, 18, 2015 at 12:30 p.m.

There being no further business up for discussion, this meeting was adjourned at 1:25 p.m.

TRIAL PRACTICE INSTITUTES

In addition to the skills necessary to perform in court, participants are taught to view cases and clients in a holistic fashion so they may appropriately address the collateral consequences of the criminal justice system and understand the underlying issues that cause clients to enter the system. I taught at this program in May 2014.

SERVICE TO THE PROFESSION AND THE PUBLIC

Pro Bono Murder Trial: In the summer of 1992 I was approached by members of the New York State Commission for the Prevention of Domestic Violence and the New York State Defenders Association to undertake the representation of a young woman accused of felony murder. The woman was a victim of severe domestic violence, and had been in jail for approximately fifteen months awaiting trial. It was the strong belief of advocates at both agencies that the woman was innocent of any crime. It was further their belief that her court-appointed attorney was not prepared to adequately represent her. The trial judge refused to substitute me as her court-appointed attorney, and would consent to her request for my representation only if I agreed to try the case without

compensation and without any requests for extension to assist in preparation. I undertook the representation, and tried the case to jury verdict. My client was acquitted and reunited with her young son.

Lawyers' Assistance Task Force: As a member of the Lawyers' Assistance Task Force of the NACDL I was asked to represent an attorney in the Monroe County (Rochester) Public Defenders Office. The attorney was threatened with contempt by a county court judge over his refusal to divulge an attorney-client confidence. I reviewed the file, researched the confidentiality issue, and assisted in the preparation of an appeal to the Appellate Division. I flew to Rochester to represent the attorney at the contempt hearing. After several hours of meetings, we were able to convince the Judge to reverse his previous order. The attorney was not forced to testify against his client, and he was not held in contempt.

NACDL: I served on the Board of Directors of the National Association of Criminal Defense Attorneys (NACDL) from 1988 through 1995. During that time I was active in the Continuing Legal Education Committee, the Lawyers' Assistance Strike Force, and the Women and Minorities Committee, which I chaired for three years. In 1996, I was appointed by the President of the organization, Judy Clarke, to serve as Parliamentarian. As such, I became a member of the Executive Committee, as well as maintaining my position on the Board of Directors. I was responsible for assisting in the governance of the organization, including its decision to file a lawsuit which resulted in the release of the FBI Lab Report to the public. I also served as the Co-Chair of the Law School Committee on Death Penalty Clinics.

COMMISSION ON JUDICIAL CONDUCT: I was appointed to serve as a referee and hearing officer on the New York Commission on Judicial Conduct in 1993 and have actively continued to serve in that capacity. My responsibilities concern judges against whom allegations of judicial misconduct have been made. As a referee I am responsible for reviewing pleadings, scheduling and overseeing pre-trial meetings with the attorneys, and presiding over trials when necessary. I am further charged with the responsibility of making findings of fact and conclusions of law, and preparing a Referee's Report for use by the Commission.

DEATH PENALTY SCREENING PANEL: I was appointed to the initial Screening Panel for the Appellate Division, Third Department with respect to death penalty cases, and served as its Chair for three years. The Screening Panels set proposed rates of compensation for attorneys appointed to represent indigent defendants facing the death penalty. In addition, it was our responsibility to set standards and to screen and approve attorneys in the Department to be placed on a list for such appointments. We also served as advisors to the Capital Defenders' Office to help it ascertain which attorneys in our Department should receive training in death penalty work. Our work came to an end when the New York Court of Appeals ruled that the death penalty statute was unconstitutional.

CAPITAL DISTRICT WOMEN'S BAR ASSOCIATION: During each election year from 1994 to 2012 I served on the Capital District Women's Bar Association Committee on Judicial Candidate Screening and Rating. The Committee performed an extensive background check and conducted interviews of candidates for all contested judicial elections in the Third Department. We then rated each candidate and publicized the ratings so that voters could make informed voting decisions. I served as Co-Chair of the Committee for two years.

CONVOCATION ON THE FACE OF THE PROFESSION: The Hon. Judith Kaye, Chief Judge of the State of New York, The New York State Judicial Institute on Professionalism in the Law, and the New York State Bar Association sponsored the two day Convocation to facilitate communication among the academy, practitioners, and the Bar Associations. At the request of the Dean, I represented Albany Law School. I was a presenter on a panel composed of academics and practitioners asked to address the issue of "Socialization of Law Students Into the Profession."

ALBANY-TULA ALLIANCE: From 2002 to 2004, I served as a Board Member and Chair of the Law Committee of the Albany-Tula Alliance, an organization devoted to improving relations between the United States and Russia through joint activities of Albany and her sister city, Tula. In May of 2002, I traveled to Tula to teach on "Criminal Procedure and Jury Selection in the United States." I taught classes at Tula State University and the Tula Pedagogical University. In addition, I presented a seminar to the criminal court judges of the Tula Region, who began conducting jury trials for the first time in July, 2002.

NEW YORK STATE BAR ASSOCIATION: I was the 3rd Department representative to the Executive Committee of the Criminal Justice Section of the State Bar Association from 2002-2006. The Committee addressed issues such as standards for indigent defense, the Patriot Act, reinstatement of the death penalty, the taping of confessions, and the reform of the Rockefeller Drug Laws. I also served as a member of the Nominating Committee for Criminal Justice Section Awards.

In 2004, I was appointed to serve on the President's Special Committee to Ensure Quality of Mandated Representation, a Committee concerned with the provision of competent representation of indigent individuals in the criminal justice and family court systems. We were charged with developing a comprehensive set of standards for appointed counsel in New York State. During the course of 2004 and 2005, the Standards were developed by the Committee, sent to other interested Committees of the Bar for comment, and were adopted by the Board of Governors at their April meeting.

COMMISSION ON THE FUTURE OF INDIGENT DEFENSE SERVICES: I was appointed by Chief Judge Judith Kaye to serve on the Commission. This Commission was charged with the task of determining the state of services throughout New York State and with making recommendations for the future delivery of such services. I

participated in meetings of the Commission and in the public hearings in New York City, Rochester, Albany, and Ithaca.

STATE BAR TASK FORCE ON WRONGFUL CONVICTIONS: I served on the Task Force and was Chair of the Subcommittee on Mistaken Identification. We conducted an extensive review of cases throughout New York to isolate and examine the causes of wrongful conviction. We then make recommendations for procedural and legislative actions that should be taken to reduce miscarriages of justice in the future. We worked with the legislature to draft appropriate language to implement our recommendations.

BREAST CANCER SURVIVOR NETWORK: I counsel and offer support to women who have been recently diagnosed with breast cancer.

SCHUYLER CENTER FOR ANALYSIS AND ADVOCACY (SCAA): I am on the Board of Directors of the SCAA, a non-profit organization that conducts policy research, analysis and advocacy to promote economic security, health and justice. The primary focus is on child welfare, early care and learning and amelioration of poverty through a living wage and access to high quality physical, dental, and behavioral heath services.
