## **RESOLUTION NO. PDSC 00-03**

WHEREAS, That on September 18, 1998, the Superior Court of Guam issued a Sentencing and Judgement Order against Carlos S. Mesa, (S.C. Case No. CF431-96) former employee of Public Defender Service Corporation; That Judgement by the Superior Court ordered the Government of Guam WHEREAS, Retirement Fund to surrender two thousand eight hundred seven dollars and fifty-five cents (\$2, 807.55) of Carlos S. Mesa's retirement fund payable to Public Defender Service Corporation; That the same Judgment also ordered Carlos S. Mesa to pay twenty-one WHEREAS, thousand seven hundred twenty-five dollars and sixty-six cents (\$21,725.66) in restitution to the Public Defender Service Corporation; WHEREAS, That on May 17, 2000, the Public Defender Service Corporation received a check from the GovGuam Retirement Fund in the amount of two thousand eight hundred seven dollars and fifty-five cents (\$2, 807.55), Check No. 60055: WHEREAS. That on May 26, 2000, the Public Defender Service Corporation received a cashier's check from Carlos S. Mesa in the amount of twenty-one thousand seven hundred twenty-five dollars and sixty-six cents (\$21,725.66), Check No. 020758; WHEREAS, That the total sum received is twenty-four thousand five hundred thirty-three dollars and twenty-one cents (\$24,533.21) and that said amount must be reverted to the General Fund since said monies taken were appropriated funds for Fiscal Years 1992 and 1993; now therefore be it RESOLVED. The Board of Trustees of the Public Defender Service Corporation, in its meeting of June 26, 2000, requests the Guam Legislature to reappropriate the amount of twenty-four thousand five hundred thirty-three dollars and twentyone cents (\$24,533.21) to the Public Defender Service Corporation to cover shortfalls in the budget for Fiscal Year 2000 due to two employees not
