WITH RESPECT TO A SPECIAL MEETING
CALLED FOR APRIL 28, 2014

RESOLUTION NO. PDSC 12-14

WHEREAS, Chapter 11 of Title 12 Guam Code Annotated established the Public Defender

Service Corporation (PDSC) in order to provide effective legal aid and

assistance to individuals on Guam who are unable to afford counsel; and

WHEREAS, §11107(a) of Chapter 11, Title 12 GCA authorizes the PDSC Board of Trustees

to exercise all powers vested in the Corporation; and

WHEREAS, the PDSC Board of Trustees had scheduled a regular meeting for April 23, 2014

and had provided Public Notice as required by law; and

WHEREAS, the Board of Trustees was not able to hold its regular meeting on April 23, 2014

due to the lack of a quorum; and

WHEREAS, it is imperative that a Special Meeting be conducted to review and approve the

Corporations Fiscal Year 2015 Budget Request, which is due for submittal to the

32nd Guam Legislature on May 1, 2014; and

WHEREAS. Public Notice requirements for this Special Meeting could not be met because of

the impending deadline for budget submittal; and

WHEREAS, §8108 of Chapter 8, Title 5 GCA provides for the waiver of Public Notice

requirements in the event of an emergency certified by the public agency; now

therefore be it

RESOLVED, the Board of Trustees of the Public Defender Service Corporation, recognizing

the urgency to meet in order to review and approve the PDSC Fiscal Year 2015 Budget Request so as to abide by the May 1, 2014 deadline, hereby certifies and declares an emergency for the purpose of waiving Public Notice for the Special

Meeting on April 28, 2014.
