the PDSC Board of Trustees was informed at its September 20, 2016 meeting that Government of Guam's Federal Programs had advised PDSC of the need to fund fifty percent (50%) of personnel cost for the Family Violence Program (FVP) Specialist for FY2017; and

WHEREAS,

the FVP Specialist has acquired the training and education, through the Federal Programs office, to help victims of domestic and family violence obtain Protective Orders through PDSC; and

WHEREAS,

the FVP Specialist will serve as the advocate for victims build relationships with other key stakeholders in order to gain specialist knowledge about the systems and services that exist to respond to the needs of victims who have experienced domestic and family violence; and

WHEREAS,

the FPV Specialist, with fifty percent (50%) funding provided by PDSC, will assist the Corporation with other duties and responsibilities to help with Criminal and Civil matters; and

WHEREAS,

the cost-share to PDSC to maintain the Domestic Violence Program within PDSC is \$25,897.14 that will be paid from lapsed funds; now therefore be it

RESOLVED,

The Board of Trustees of the Public Defender Service Corporation, in its meeting of August 22, 2017 hereby approves the Corporation's request for the expenditure of **\$25,897.14** of lapsed funds for the purposes described above, and as specified on the attachments hereto, which are made a part of this resolution.
