# BEFORE THE BOARD OF TRUSTEES OF THE PUBLIC DEFENDER SERVICE CORPORATION RELATIVE TO ESTABLISHING THE ELDER JUSTICE CENTER AS A PERMANENT DIVISION

#### RESOLUTION NO. PDSC 01-23

WHEREAS, on July 28, 2020, this body adopted Resolution No. 06-20 wherein the Public

Defender Service Corporation ("PDSC") was authorized to operate a pilot program known as the Elder Justice Center ("EJC") for six months in duration

from the adoption of the Resolution; and

WHEREAS, Resolution No. 01-22, established the EJC as a permanent division of the PDSC

on October 26, 2021; and

WHEREAS, Resolution No. 06-20 obligated PDSC management to periodically provide the

PDSC Board of Trustees (the "Board") with information on case statistics, expenses, and other information concerning the work provided by the EJC. These updates have occurred over the past twelve months, at regularly scheduled Board

of Trustee meetings; and

WHEREAS, since the EJC opened its doors, the team has provided services to those cases

previously waitlisted by the Public Health and Social Services, Division of Senior Citizens ("DPHHS") and has completed services and cleared all waitlists and is now providing services as clients arrive in keeping with the original goal of the

EJC and the Board before addressing other needs of the senior community; and

WHEREAS, as of January 2022 through September 16, 2022 the EJC has closed three hundred

and seventy-six (376) cases providing six hundred and ninety-three (693)

services; and

WHEREAS, the Memorandum of Understanding (MOU) between DPHHS and PDSC dated

August 31, 2020 states, "the broad purpose of the Legal LAS (Legal Assistance Services) Program is to focus outreach and services particularly directed toward the most socially or economic needy older persons (those least likely able to advocate on their own behalf) to assist them to: understand their rights; exercise choices; benefit from services, opportunities and entitlements; meet essential needs of income, shelter, health care and nutrition; and maintain the rights

promised and protected by law" (see MOU at 11); and

WHEREAS, the MOU restricts the priority of services to those based on "urgency of need

related to income, health care, adult day care admission, long term care, nutrition, housing, including landlord-tenant issues primarily in defense against evictions, utilities, protective services, defense of guardianship, abuse, neglect, age discrimination regarding employment, consumer issues in cases that reflect a

pattern of fraud against the elderly as a group, and public benefits. Services shall

include Advance Directives including powers of attorney, restraining orders, guardianships of the person and wills;" and

## WHEREAS,

pursuant to the MOU, the EJC limits representation to those cases that are not fee-generating and where lawyers are not available to assist our seniors in the most essential needs of shelter, food and healthcare while setting a priority to those who are most socially or economic needy and those seniors are least likely able to advocate on their behalf; and

#### WHEREAS,

the EJC receives \$192,144.00 funding as a sub-grantee of the DPHHS, Legal Assistance Services Program and additional funding from American Rescue Plan Act ("ARPA") in the amount of \$1,572,873. This additional funding will extend to Fiscal Year 2025; and

# WHEREAS,

the needs of the senior community as expressed by seniors through surveys and through inquiries at the EJC has shown there is a need to address landlord/tenant issues, probate, medical billing, scams, Medicare, GHURA housing and other issues; and

#### WHEREAS.

the community of seniors (*Manåmko*) on Guam is defined by 10 G.C.A. §8102(d) as fifty-five years of age and above, the Legal Assistance Services Program is limited to helping seniors 60 and older and a gap therefore exists; and

### WHEREAS.

the EJC's current staff of 2.5 attorneys and support staff is adequately equipped with sufficient resources to handle additional services; it is now therefore

# RESOLVED

the PDSC shall continue to administer the services of the Elder Justice Center as previously approved by the Board and provided in this Resolution.

The services are to be extended to Guam's seniors (Manamko) beginning at age fifty-five and older.

Guam's seniors (Manåmko) within the age of fifty-five and fifty-nine will only be assisted until such time that the American Rescue Plan Act ("ARPA") funds are exhausted or at the end of the ARPA program year of December 31, 2025.

The EJC's services will be expanded to include giving general advice to qualifying tenants which will include assessment, legal advice, instruction, referral when appropriate and representation primarily in defense against evictions to protect essential shelter.

The EJC is also permitted to provide advice, instruction, and referral when appropriate in the areas of health care, adult day care admission, long-term care, utilities, protective services, guardianship, abuse, neglect, consumer issues in

cases that reflect a pattern of fraud against the elderly as a group, and defense against revocation of public benefits and/or assistance.
