# Hubbard's return lifts Bengals over Ravens

CINCINNATI (AP) — Sam Hubbard returned Tyler Huntley's fumble 98 yards for a tiebreaking touchdown in the fourth quarter, helping Joe Burrow and the Cincinnati Bengals beat the Baltimore Ravens 24-17 in an AFC wild-card game on Sunday night.

Facing third-and-goal at the 1 with about 12 minutes left, Huntley tried to go over the top of the line for the go-ahead score. But he was stood up by Germaine Pratt and stripped by fellow linebacker Logan Wilson.

The ball went right to Hubbard at the 2, and the defensive end took off down the field for the longest fumble return for a touchdown in NFL postseason history. It also was the longest go-ahead TD in the fourth quarter in the postseason.

Moments after the play by the Cincinnati native, with the Paycor Stadium crowd of 66,399 still buzzing, Hubbard sucked on oxygen as he sat on the bench on the sideline.

"Just a credit to whoever punched that ball out. I

was in the right place at the right time," Hubbard said.

Baltimore drove down to the Cincinnati 17 in the final minute, but Kevin Zeitler was flagged for holding and Huntley threw incomplete to the end zone on the final play.

Playing behind a patchwork offensive line, Burrow passed for 209 yards and a touchdown for the AFC North champions. He also had a 1-yard touchdown run a week after the Bengals beat the Ravens 27-16 in the regular-season finale.

"Hard-fought. That's how it is in the playoffs, especially when you play a divisional team for a third time," Burrow said. "It's never going to be easy. They know us. We know them. It's nice to get the win."

Next up for Cincinnati (13-4) is a trip to Buffalo for a rematch of their Week 17 game that was canceled after Bills safety Damar Hamlin went into cardiac arrest on the field. With Hamlin watching from home, Buffalo advanced with a 34-31 victory over Miami on Sunday.

costly interception. Hubbard's dramatic trip to the end zone sent the Ravens into a uncertain offseason centered around the future of Jackson, who is eligible for free agency. The 2019 MVP got hurt during a 10-9 win against Denver on Dec. 4, and he did not travel with the team to Cincinnati for the playoff game.

Jackson once again because of the quarterback's knee injury, Baltimore (10-8) managed two offensive

touchdowns for the first time since Nov. 27. Huntley passed for 226 yards and two TDs, but he also had a

# Bills focus on playing with Hamlin home

ORCHARD PARK, N.Y. (AP) — Damar Hamlin is back on his feet, and that's uplifting enough in allowing coach Sean McDermott and the Buffalo Bills to focus on their immediate future rather than an emotional past in preparing to host the Cincinnati Bengals in an AFC divisional play-off on Sunday.

In some three weeks time, the Bills — and the Bengals for that matter, too — have gone from having their game canceled after Hamlin went into cardiac arrest and needing to be resuscitated on the field in

Cincinnati, to being consoled by the safety's remarkable recovery.

"I think the guys are in a good spot," McDermott said on Wednesday in noting Hamlin has made regular visits to the Bills facility

this week.

"As he continues to improve, I think that certainly helps," McDermott added. "That experience, we'll carry with us, and there's a challenge to that. But there's also a lot of good

that came from that. And I think right now, we need to focus on the positives."

The positives are numerous, and start with Hamlin back home a week after being released from the hospital. There's also the out-

pouring of support Hamlin received in the wake of his sudden collapse.

And McDermott believes the passing of time helped ease whatever emotional residue he and his players felt.

**I. CALL TO ORDER**

The meeting was called to order at 12:30 p.m. on December 27, 2022 by Chairman Chief Justice F. Philip Carbullido.

**II. ROLL CALL**

**III. PROOF OF DUE NOTICE OF MEETINGS**

“Notice of Public Meeting” was published in the Pacific Daily News on Tuesday, December 20, 2022 and Friday, December 23, 2022.

**IV. DETERMINATION OF QUORUM**

With the presence of three (3) out of the five (5) board members, a quorum was determined for the meeting to proceed.

V. **APPROVAL OF MINUTES**

Chairman Chief Justice Carbullido extended, on behalf of the board, deepest condolences to Executive Director Stephen Hattori for the tragic death of his sister, Dr. Margaret Hattori-Uchima. A moment of silence was observed to honor the late Dr. Margaret Hattori-Uchima and her contributions to Guam's healthcare community.

Chief Justice Carbullido proceeded with the approval of the minutes of the regular board meeting of November 25, 2022.

**Motion to adopt the minutes subject to correction was made by Trustee Ecube and seconded by Chief Justice Carbullido. Approved by acclamation.**

VI. **OLD BUSINESS**

A. **FINANCIAL STATUS UPDATE/ALLOTMENT RELEASES (PDSC, APD, CLC)**

CFO Moreno reported that December's second allotment was received on December 22<sup>nd</sup>. PDSC is operating at 93% while APD is at 94% of total allotments requested.

The balance as of this meeting for the Access to Counsel Grant Program is \$10,640. Invoices for FY2023's first quarter will be submitted in January.

Regarding The Advocacy Center (TAC) and Improving Criminal Justice Response (ICJR) grants, the balance for ICJR as of November 30<sup>th</sup> is \$109,000 and is being used by both programs for reimbursements.

We have the signed FY2023 MOU for the Elder Justice Center (EJC); however, we have not received payment for October and November invoices. Per Division of Senior Citizens (DSC), the September invoice was sent on November 8, but has yet to be processed as of this meeting. DSC will continue to follow up with DOA relative to payments. We understand, initially, that the payments for these invoices were awaiting receipt of the signed MOU by DOA. Chief Justice Carbullido suggested that PDSC submit in writing a follow up to DSC regarding the outstanding reimbursements.

B. **REPORT FROM PDSC EXECUTIVE DIRECTOR**

ED Hattori stated they reviewed their conflict of interest procedures from 2014 and will implement a new procedure where a senior attorney will co-sign any withdrawal motions. They plan to tighten their SOP regarding withdrawals due to prior representation of co-defendants and victims. PDSC's new procedure also includes a conflict sheet with a list of scenarios for per se conflicts such as personal conflicts between attorneys and clients as well as personality conflicts. Once PDSC finalizes its performance standards they will allow the private attorney panel access to their brief bank to assist them with withdrawal procedures and criminal matters.

Chief Justice Carbullido responded that he is satisfied with the written policy and stated a list of scenarios is not necessary. Trustee Ecube stated she is comfortable with the new procedure and agrees that a list of scenarios is not necessary. She asked that language be provided that will allow for future modifications and that automatic withdrawals without permission either be removed from the policy or require a co-signer. Trustee Ecube also asked that the other trustees provide feedback on the matter and move forward with adoption. Chief Justice Carbullido asked ED Hattori to prepare in written form an amended policy inclusive of Trustee Ecube's recommendations and they will act on the matter at a later meeting when all the trustees are present. ED Hattori stated they will have a resolution prepared based on the recommended changes. Chief Justice Carbullido added that he appreciates the new changes to the SOP because it allows the Court to avoid reverting back to the old system of reassigning cases through the Guam Bar listing until such time a qualified attorney accepts a case.

C. REPORT FROM APD MANAGING ATTORNEY

MA Gayle reported that APD received 28 new cases for the month of November and withdrew from 63 cases bringing their number to 15%. Attorney Brycen Breazeale submitted his resignation notice effective January 6, 2023. APD's newly hired attorney Brian Scanlon is expected to start in the next year. Chief Justice Carbullido asked that APD's statistics be sent to the board members since it was not included in this meeting's board packet and inquired about APD's recruitment for attorney positions. MA Gayle responded that until now, APD has not had to do major outreach efforts to fill vacancies. Chief Justice Carbullido stated that he would like the position and pay scale to be advertised and circulated throughout Micronesia via the Pacific Judicial Council. MA Gayle stated she will work with ED Hattori on announcing this vacancy.

D. REPORT FROM EJC MANAGING ATTORNEY

Acting MA Siguenza reported that EJC is operating successfully and continues to meet their required numbers which MA Hanes will present at the next board meeting. She continued that Trustee Terlaje has authorized her to report that the two of them will be updating the Guam Bar Association's list of real estate and estate attorneys which will help EJC's clients in seeking out attorneys. Attorney Siguenza also mentioned that the PJC's speaker from Washington DC on holistic approach was very helpful and Chief Justice Carbullido added that the speaker stated that EJC, PDSC and APD are all on the right track in terms of managing their affairs.

E. ATTORNEY PAY PARITY

ED Hattori stated that we will wait for the new Legislature to be sworn in before submitting a letter to the Speaker regarding re-introducing the bill that corrects the pay between PD and the AG's Office. Chief Justice Carbullido commented that PDSC get an early start on this so that this item get on the Legislature's agenda.

F. CONFLICT OF INTEREST (SOP)

This matter was discussed earlier in the meeting under “Report from PDSC Executive Director.”

VII. NEW BUSINESS

None.

VIII. PUBLIC DISCUSSION

None.

IX. ADJOURNMENT AND NEXT MEETING DATE

ED Hattori inquired if this meeting will be the last with this board. Chief Justice Carbullido stated he will rotate out and that PDSC may want to inform his successor if any new trustee appointments are to be made. ED Hattori thanked Chief Justice Carbullido his support in helping move PDSC, EJC and APD forward and ensuring that EJC gets on firm ground. Chief Justice Carbullido responded that it has been an honor to serve on this board. Trustee Ecube the echoed the words of ED Hattori.

With no further matters to discuss, **motion was made by Trustee Quinata and seconded by Trustee Ecube to adjourn the meeting. Approved by acclamation.**

The next BOT meeting is scheduled for Tuesday, January 24, 2023 at 12:30 p.m. in the PDSC conference room via Zoom/YouTube.

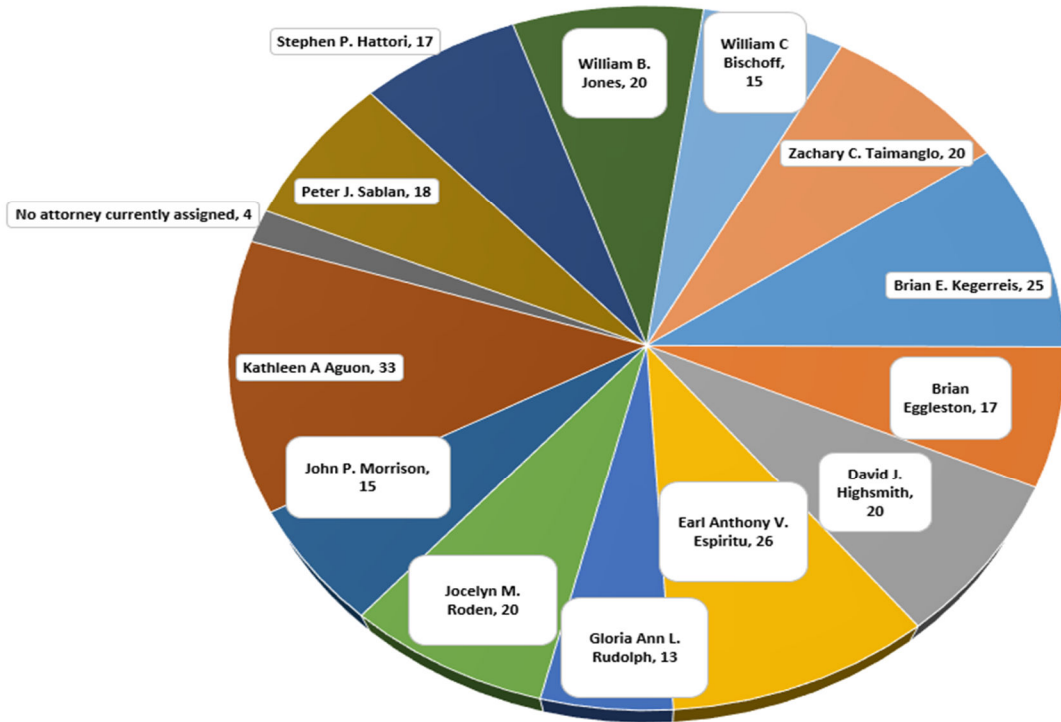

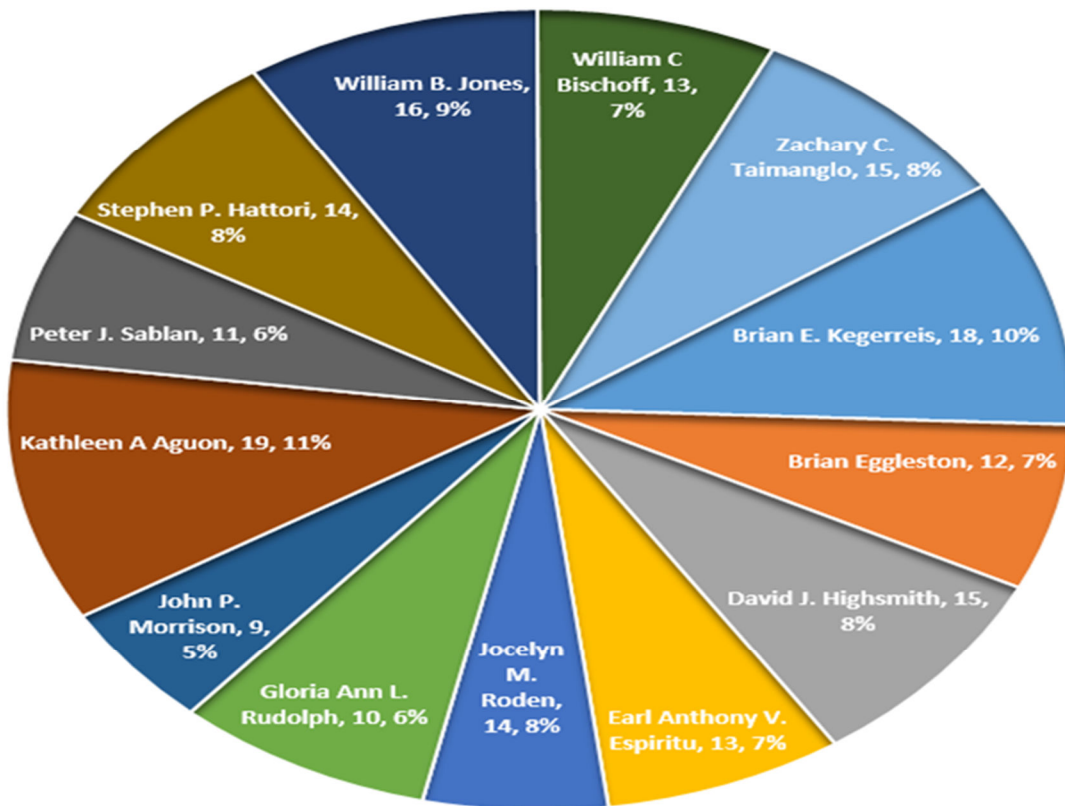
