#### Showtime

The March 16 showtime is at 5 a.m. for all participants.

The go time for runners that choose to participate in the 10K distance is at 5:45 a.m., and the 5K distance at 6 a.m.

Early bird registration started on Jan. 8 and will continue until Jan. 28 with a fee of \$25 for the 5K run and \$25 for the 10K run.

The fee from Jan. 29 to March 7 will be \$25 for the 5K run and \$30 for the 10K run.

The fee for late registration beginning March 8 and 9 will be \$30 for the 5K run and \$35 for the 10K run.

Unofficial registration (no chip timing) will be from March 10 through 16 at select Pay-Less Supermarkets locations. Unofficial registration locations will be posted online.

A mandatory packet pick-up will be on March 9 at the Guam Elite Basketball Association National Training Center/Gym at Tiyan, Barrigada.

The first 1,500 5K finishers will receive a Run Guam t-shirt and a reusable bag.

The first 300 10K finishers will receive a Run Guam singlet and a reusable bag.

All registered runners will also be entered into a raffle to win prizes, including a grand prize of \$600 in Pay-Less gift certificates.

A \$500 cash prize will be awarded to the school with the most participation.



#### MINUTES

#### I. CALL TO ORDER

The meeting was called to order at 12:32 p.m. on November 24, 2023 by Chairman Chief Justice Robert J. Torres.

#### II. ROLL CALL

#### III. **DETERMINATION OF QUORUM**

With the presence of three (3) out of the five (5) board members, a quorum was determined for the meeting to proceed.

#### IV. **PROOF OF DUE NOTICE OF MEETINGS**

"Notice of Public Meeting" was published in the Pacific Daily News on Tuesday, November 21, 2023 and Friday, November 24, 2023.

#### V. <u>APPROVAL OF MINUTES</u>

Chairman Chief Justice Torres stated they will proceed with the approval of the minutes of the regular board meeting of October 24, 2023.

### Motion to adopt the minutes subject to correction was made by Trustee Quinata and seconded by Trustee Whitman. Approved by acclamation.

#### VI. OLD BUSINESS

#### A. <u>FINANCIAL STATUS UPDATE/ALLOTMENT RELEASES (PDSC, APD,</u> <u>CLC)</u>

AD Gogue stated PDSC and APD received \$908,403.00 for their allotments since the last board meeting bringing the total received at 91 percent.

The Improving Criminal Justice Response grant (ICJR) has a balance of \$41,207.00. The balance is being used for The Advocacy Center's (TAC) STOP grant. The cost for personnel is \$42,207 while Travel and Supplies is \$9,204. STOP 2022 is still pending approval with Federal Programs' Office at the Governor's office.

As of this meeting, EJC has received all of its FY2023 funding DPHSS as requested and the invoice for October 2023 for \$22,618.93 has been submitted for reimbursement.

The Access to Counsel grant has a balance under \$100 and should be closed out with BSP. Any remaining funds will be returned to BSP.

#### B. <u>REPORT FROM PDSC EXECUTIVE DIRECTOR</u>

ED Hattori reported that the year-to-date stats for FY2024 show an increase of 1,155 cases which is down from prior years mainly because all non-criminal cases were shifted to CLC. Stats provided are broken down into felonies, misdemeanors, and bench warrants. Stats also include cases of attorneys who are no longer with PDSC that get reassigned to another attorney, if needed. Attorney C. Spotanski has left PDSC and PD is hoping to replace him shortly. Chief Justice Torres advised that moving forward, the stats should be broken down into pre and post matters.

Chief Justice Torres continued that the criminal felony panel has been reduced to two attorneys, both of whom have asked that no more cases be assigned to them for the next few months. He asked that PDSC and APD consider ways to avoid conflicting out of cases such as 'walling off' attorneys and ensuring that withdrawals are warranted. ED Hattori responded that MA Hinkle-Sanchez will speak more on that in her report and that PDSC will re-examine their conflict cases.

#### C. <u>REPORT FROM APD MANAGING ATTORNEY</u>

MA Gayle stated that funeral services for Attorney Spivey will take place this weekend and all are invited to attend either in-person or via Zoom.

APD stats provide a monthly count of cases and year-to-date numbers can be provided at the next meeting.

MA Gayle stated that the Court has asked APD to reevaluate cases that were reappointed to Attorney Spivey to determine if true conflicts exist. She responded that this is being done on a case-by-case basis.

Chief Justice Torres asked that a year-end report be provided as well as a breakdown of misdemeanors and felonies which MA Gayle confirmed she will provide.

#### D. <u>REPORT FROM CLC MANAGING ATTORNEY</u>

MA Hinkle-Sanchez reported that CLC has had a total of 546 clients to date. A bulk of the cases are EJC's because many of the clients are receiving multiple services.

CLC will now be appointed *guardian ad litem* cases and are looking to establish a volunteer program within CLC to utilize social workers, through an internship program, with University of Guam. This arrangement with UOG will be cost-effective for the Court and helpful to CPS in hiring trained social workers after the program is complete. She advised the board that more information will be presented on this program once MA Hinkle-Sanchez has completed her research.

MA Gayle stated that APD's end-of-year stats were actually included in the last BOT meeting packet.

#### VII. **NEW BUSINESS**

None.

#### VIII. **<u>PUBLIC DISCUSSION</u>**

None.

#### IX. ADJOURNMENT AND NEXT MEETING DATE

Chief Justice Torres suggested that the next board meeting be in-person depending on the Trustees' schedules and new business topics.

#### With no further matters to discuss, <u>motion was made by Trustee Quinata and seconded</u> by Trustee Whitman to adjourn the meeting. Approved by acclamation.

The next BOT meeting is scheduled for Tuesday, December 26, 2024 at 12:30 p.m. in the PDSC conference room via Zoom/YouTube.
