The Guam Housing and Urban Renewal Authority's (GHURA's) 2024 Low Income Housing Tax Credit (LIHTC) Program Qualified Allocation Plan (QAP) and Application are now available. The QAP describes the basis that GHURA will use to allocate LIHTC Program credits. A total of \$6,545,000 (\$3,185,000 issued on October 18, 2022 under Rev. Proc. 2022-38 for CY2023 allocation and \$3,360,000 issued on November, 2023 under Rev. Proc. 2023-34 for CY2024 allocation) for the 2024 LIHTC QAP Application

GHURA is the recognized state housing credit agency authorized to allocate LIHTC Program credits in Guam. The United States 1986 Tax Reform Act created the federal low-income housing tax credit under Section 42 of the Internal Revenue code (the Code). The LIHTC program assists in the development of low-income rental housing by providing qualified owners with tax credits to offset their federal tax obligations. LIHTC Program credits are available to owners of qualifying buildings and projects that meet certain low-income occupancy rent restrictions.

Section 42 of the Code provides that Guam prepare a QAP to determine housing priorities and to give preference to projects serving the lowest income tenants and projects obligated to serve qualified tenants for the longest periods. The QAP must incorporate selection criteria which include project location, housing need characteristics, sponsor characteristics, and tenant populations with special needs.

Applications are available beginning Thursday, July 25, 2024 from GHURA's website at www.ghura.org. Applications are due on Friday, October 25, 2024. There is a \$1,500.00 Application Fee due upon submission. Applications must be submitted at **GHURA's Main Office** in Sinajana at 117 Bien Venida Avenue, Sinajana, GU 96910 by no later than 5:00 pm.

MINUTES

I. CALL TO ORDER

The meeting was called to order at 12:30 p.m. on July 23, 2024 by Vice Chairman Presiding Judge Alberto C. Lamorena, III.

II. ROLL CALL

III. DETERMINATION OF QUORUM

With the presence of four (4) out of the five (5) board members, a quorum was determined for the meeting to proceed.

IV. PROOF OF DUE NOTICE OF MEETINGS

"Notice of Public Meeting" was published in the Guam Daily Post on Tuesday, July 16, 2024 and Friday, July 19, 2024, and posted on Government of Guam's Public Notices Portal. Acting AD Moylan clarified that there is an error on the agenda concerning the second notice. The correct date is July 19, 2023.

V. APPROVAL OF MINUTES

Presiding Judge Lamorena stated they will proceed with the approval of the minutes of the regular board meeting of June 25, 2024.

Motion to adopt the minutes was made by Trustee Quinata and seconded by Trustee Whitman. Approved by acclamation.

VI. <u>OLD BUSINESS</u>

B. REPORT FROM PDSC EXECUTIVE DIRECTOR

Presiding Judge Lamorena asked ED Hattori to start with PDSC's report. ED Hattori stated that as of June 30, 2024 there are 1,242 active pre-judgment cases, 808 active pre-judgment bench warrant cases, 2,647 post-judgment cases and 903 post-judgment cases with outstanding bench warrants. That is a total of 5,600 open cases. Eighty-seven cases were opened in June 2024 compared to 132 in June 2023. Majority of the cases were felonies. Seventy cases were closed in June. Of those, six were closed due to conflict, four due to exceeded income and one due to substitution of counsel.

Regarding Electronic Monitoring (EM), Chief Investigator Call found that 69 packets were filed this year, 48 of which included declarations. Currently, there are 83 defendants on EMP release. PDSC continues to increase the amount of clients on EMP release given the state of the Department of Corrections.

PDSC has reached out to SCOG's Criminal Case Manager regarding bail motions. A meeting with the Clerk of Court will be set soon.

Lastly, ED Hattori reported that the Administrative Director position announcement will be posted this week and remain open for 30 days. Chief Justice Torres added that SCOG will assist with the rating process.

A. <u>FINANCIAL STATUS UPDATE/ALLOTMENT RELEASES (PDSC, APD, CLC)</u>

CFO Moreno reported that PDSC received \$605,602 after the last board meeting, bringing both PDSC and APD to 97%.

As of June 30, 2024, Improving Criminal Justice Response (ICJR) Grant had expenditures of \$136,596 for Personnel and \$22,445 for Travel, Supplies and Equipment. Balances are \$25, 506 for Personnel and \$1,448 for Operations. This will be used until STOP 2022 funds are appropriated. STOP 2021 was closed at \$24,418.

The Elder Justice Center (EJC) submitted invoices totaling \$80,023 for February to June 2024, but payments have not been received as of this meeting. A signed copy of the MOU is still pending from Department of Public Health and Social Services (DPHSS).

A quarterly report for JAG Access to Counsel Grant was issued this month. The total amount of \$26,658 was expended.

An invoice for \$1,242 for June 2024 regarding WestCare's grant for legal services for veterans was submitted, but payment has not been received. Payments for all other invoices have been received.

C. REPORT FROM APD MANAGING ATTORNEY

MA Gayle reported that APD has 84 felony cases, 24 misdemeanors and 29 juvenile and PINS cases. There was a total of 142 cases for third quarter. To date, APD has a total of 391 cases. She added that more felony cases have been received than misdemeanor cases.

Regarding EM, APD completed 65 packets, 37 of which were submitted, 16 were granted and 23 were considered ineligible. She continued that the stats need to be updated due to some clients being placed on EM prior to APD being made aware at magistrates hearings. APD continues to work with Probation to ensure the stats are aligned.

Presiding Judge Lamorena agreed that more felonies are being filed than misdemeanors.

D. REPORT FROM CLC MANAGING ATTORNEY

MA Hinkle-Sanchez reported that The Advocacy Center has received more referrals from the Attorney General's Office. EJC continues to receive 40 to 50 cases per month hence their intention to provide remote clinics to various communities. To date, there is a total of 138 open cases where they provided 242 services.

CLC continues to receive guardianship referrals from Child Protective Services and juvenile special proceedings appointments. The total referrals from the OAG is seven; however, that number may be higher. MA Hinkle-Sanchez stated they have 29 referrals from GPD. Presiding Judge Lamorena suggested she speak with AG Moylan regarding the increase in referrals and that she track them because they were not anticipated. He asked that she find out what their policy is so that CLC can make adjustments and modify next year's budget, if needed.

E. EXECUTIVE DIRECTOR COMPENSATION & CLASSIFICATION

ED Hattori proposed this matter be tabled until after his evaluation is completed. There were no objections.

F. SIXTH AMENDMENT CENTER PROJECTS

ED Hattori reported that for Finding #1, both PDSC and APD are now tracking temporary case assignments. Such instances are clients that in jail who are financially over-qualified, but eventually qualify if they become unemployed.

Finding #2 of the report regarding constructive denial of counsel may be incorrect. He believes they are referring to clients that are issued a Notice to Appear (NTA) and stated PDSC has reached out to Guam Police Department's S. Ignacio to inform those individuals to seek PDSC's services.

Chief Justice Torres inquired about proposed legislation to create a commission. ED Hattori stated that they are going to set up a meeting via Zoom and could include the Trustees. Chief Justice Torres said he will wait until the recommended statute is drafted to provide comment.

ED Hattori continued with Finding #3 regarding adequate attorney standards. While Guam standards are based solely on years of experience, PDSC believes actual case experience trumps that when determining promotions and hiring. PDSC will present its policy on this matter to the Trustees once it is finished.

Regarding Finding #4 on non-panel attorneys' case appointments, PDSC has assisted other attorneys when asked.

Findings #5/6 is Guam's lack of collection and analyses of information relative to determining workloads of indigent defense attorneys. PDSC and APD will soon be able to explain attorney caseloads based on workload standards using results of the latest nationwide study as a starting point. This can be completed without technical assistance.

Going back to the commission, ED Hattori stated it would all come down to funding. In terms of financial eligibility, PDSC submitted a survey last year to the Guam Bar Association. A report and guidelines will be submitted to the Trustees soon. Additionally, PDSC continues to work on a third conflict panel.

Chief Justice Torres stated this item should stay on the agenda and any progress should be reported to the Trustees. Presiding Judge Lamorena added that PDSC should continue to track the number of NTAs received for both felony and misdemeanor cases.

Motion to add grievances and complaints to the next meeting's Executive Session made by Trustee Quinata and seconded by Trustee Whitman. Approved by acclamation.



Performance Evaluation Summary of Public Defender Service Corporation (PDSC) Executive Directors:

- Nov 21, 2003 Board of Trustees (BOT) appoints Kathleen Maher as Executive Director.
 - Dec 1, 2005 the BOT writes a letter to Senator Robert Klitzkie informing that Mrs. Maher was evaluated as of Sept 30, 2005 and that the BOT decided to retain Mrs. Maher in position.
 - Unfortunately PDSC does not have a copy of that evaluation.
- 2008-09 BOT prepares a narrative of goals & accomplishments for <u>ED Mike Nisperos</u>. The subcategories within were:
 - Working with the Board of Trustees
 - Working with attorneys & staff
 - Professional/Ethical standards
 - Quality of work
 - Overall rating was 2.2 of 3.0
- July 29, 2011 BOT develops a performance evaluation for <u>ED Mike Nisperos</u> similar to a survey on various rating criteria. The categories of rating ranged from unsatisfactory, needs improvement, fully capable, exceeds expectations, & outstanding.
 - The BOT rated ED Mike Nisperos with an overall score of Outstanding.
- Mar 1, 2013 Feb 21, 2014 BOT uses Agency Head's Performance Review form referencing (5GCA §43202) for <u>ED Eric Miller</u>. There were six sections for evaluation:
 - Administration
 - Interpersonal skills
 - Individual knowledge & training
 - Leadership
 - Board relationship
 - Community relations

The BOT rated ED Eric Miller with a satisfactory rating.

- Feb 2014 Feb 2015 BOT performance evaluation on <u>ED Eric Miller</u> is blank.
 - The BOT continued the performance evaluation rating each month until the Board meeting on Oct 27, 2015 in which they came to final discussion and evaluation of ED Miller during executive session.
 - On Dec 1, 2015 during the Board meeting ED Eric Miller announce that he will be retiring on Jan 22, 2016.
 - Unfortunately PDSC does not have a copy of the evaluation.

- Mar 14, 2016 Mar 14, 2017 BOT performance evaluation of <u>ED Stephen Hattori</u> was conducted via survey and suggestions of improvement. The evaluation criteria were:
 - Leadership
 - Management
 - Communication
 - Policy matters
 - Employee development
 - Board Relationship
 - Client & Community relations

The BOT rated ED Stephen Hattori with 2.65 of 5.0.

- Oct 27, 2020 BOT meeting Executive Session notes indicate:
 - That <u>ED Stephan Hattori</u> will <u>continue in the position but that no salary increment</u> will be approved due to "economic circumstances of Government of Guam". ED Stephen Hattori acknowledges the BOT decision and continues in position to the present time.
 - This was the last time the BOT conducted a performance evaluation on ED Stephen Hattori.
 - Unfortunately PDSC does not have a copy of the evaluation.

NOTE: 5GCA CH43 §43202 Performance Reviews of Agency Heads.

The governing Boards for all agencies, instrumentalities, or entities shall issue performance reviews of the Chief Executive selected for that agency six (6) months after appointment of the said Chief Executive and every twelve (12) months thereafter that the Chief Executive is retained by the Governing Board. Each performance review shall document the Chief Executive's performance, accomplishments, and the respective Governing Board's reasons for retaining the said Chief Executive. SOURCE: Added by P.L. 27-20. Amended by P.L. 29-061:2 (Apr. 4, 2008)

It is recommended that the Performance Evaluations of the Executive Director occur more consistent on an annual basis as stated in the above law. In addition that the evaluations be held in record by the BOT and the PDSC.

 - Rating given was within the 85%-100% excellent range.
- <u>Feb 25, 2016</u> the Board of Trustees (BOT) uses the PDSC Employee Performance Evaluation Report form in rating Ms. AnaMaria Gayle for period Sept 27, 2014 to Sept 27. 2016.
 - Rating given was within the 85%-100% excellent range.
 - An employee survey was conducted that rated her the following areas: Leadership, Management, Communications, Policy Matters, Employee Development, Board Relationship, and Client & Community Relations.
- Aug 30, 2017 the Board of Trustees (BOT) uses the PDSC Employee Performance Evaluation Report form in rating Ms. AnaMaria Gayle for period Sept 27, 2015 to Sept 27, 2016.
 - Rating given was within the 85%-100% excellent range.
 - Oct 2016 an employee survey was conducted different from the previous year. Survey content gaged the opinion of APD staff on Ms. Gayle, where the Weighted Average was about averaging 3 in a range of 0 to 10.
 - Aug 22, 2017 Ms. Gayle provided a letter to the BOT stating improvements she had accomplished since the survey. These improvements focused on services to clients and office operations. The BOT thus found favor in the report and therefore resulted with the above rating.
- <u>Dec 17, 2019</u> APD Managing Attorney A. Gayle provided a letter the BOT reflecting the updates to the goals set since the 2017 evaluation.
- Apr 18, 2022 the Board of Trustees (BOT) uses the PDSC Employee Performance Evaluation Report form in rating Ms. AnaMaria Gayle for period Sept 27, 2020 to Mar 27, 2022.
 - Rating give was 80% within the Very Good level.
 - Nov 18, 2020 Ms. Gayle submitted a Position Description Questionnaire summarizing her duties, responsibilities, and functions.
 - Nov 17, 2020 a survey by Survey Monkey was conducted and provided as reference to the BOT.

Note: It is recommended that the BOT conduct yearly performance evaluations on the Managing Attorney position to align with 5GCA CH43 §43202, and that these records be held with the BOT & PDSC.
