MINUTES

I. CALL TO ORDER

The meeting was called to order at 12:35 p.m. on November 26, 2024 by the Vice Chairman Presiding Judge Alberto C. Lamorena, III.

II. ROLL CALL

III. <u>DETERMINATION OF QUORUM</u>

With the presence of four (4) out of the five (5) board members, a quorum was determined for the meeting to proceed.

IV. PROOF OF DUE NOTICE OF MEETING

"Notice of Public Meeting" was published in The Guam Daily Post on Tuesday, December 24, 2024 and Friday, December 27, 2024, and posted on Government of Guam's Public Notices Portal.

V. <u>APPROVAL OF MINUTES</u>

Presiding Judge Lamorena stated they will proceed with the approval of the minutes of the regular board meeting of November 26, 2024.

Motion to adopt the minutes was made by Trustee Quinata and seconded by Trustee Whitman. Approved by acclamation.

VI. <u>OLD BUSINESS</u>

A. <u>FINANCIAL STATUS UPDATE/ALLOTMENT RELEASES (PDSC, APD, CLC)</u>

CFO Moreno reported that November and December allotments totaling \$1,367,776 was received. Of that, PDSC received \$1,086,072 while APD received \$281,704. PDSC and APD are operating at 90% and 91%, respectively.

As of this meeting, three allotments totaling \$161,388 were received for CLC, but will not be utilized until ARPA funding is exhausted.

Invoices for the Improving Criminal Justice Response (ICJR) grant were issued for September (\$6,402), October (\$9,380) and November (\$8,001) totaling \$23,784.

Invoices for STOP were issued for October (\$11,438) and November (\$904.77) totaling \$12,343. Payments have not been received for either of these invoices.

Payments to EJC for FY2024 totaling \$85,864 have not yet been received. PDSC continues to follow-up with DPHSS regarding these payments. A Release of Claim was admitted for these payments. Invoices for October and November at \$18,914 each were also submitted, but have not been received.

B. <u>REPORT FROM PDSC EXECUTIVE DIRECTOR</u>

ED Hattori reported there are 1,992 pre-judgment cases including bench warrants. There are 3,200 post-judgment cases including 933 bench warrants. Seventy cases were opened in November which is slightly lower than prior years possibly due to the transfer of civil matters to CLC. There are 1,869 released clients and 340 that are detained.

Chief Investigator Call reported that there were 92 applications submitted for electronic monitoring, 27 of which were eligible, 40 were ineligible and 25 are pending. Thirty-three clients were granted release while 14 were denied and one revoked. All applications are for pre-trial cases.

ED Hattori continued that PDSC will be meeting with Guam Regional Transit Authority representatives soon regarding client bus passes.

C. REPORT FROM APD MANAGING ATTORNEY

Attorney P. Santos reported that APD is showing a downward trend in case numbers. Thirty-two cases were opened in November bringing their total to 471 for 2024. There are 76 cases to date for FY2025. Updated stats will be provided at the next meeting.

Presiding Judge Lamorena asked that PDSC and APD provide a census of clients receiving bus passes.

Acting AD Call asked that the Resolution regarding MA Gayle's evaluation be signed where Presiding Judge Lamorena stated that because it was not on the agenda, they cannot move forward with the discussion and advised it be placed on the next meeting's agenda.

D. REPORT FROM CLC MANAGING ATTORNEY

MA Hinkle-Sanchez reported that there is a significant increase in case numbers from prior years. December brings their caseload to over 100. CLC continues to participate in outreach events and conduct needs assessments. A full report will be submitted to the Board. A MOU with UOG's Social Work and Criminal Justice Programs was signed to engage graduates with guardianship cases and a senior legal clinic. MA Hinkle-Sanchez will be meeting with Guam Bar President Terlaje soon to discuss other programs.

E. <u>EXECUTIVE DIRECTOR COMPENSATION AND PAY INCREMENTS FROM</u> 2020 TO PRESENT

Presiding Judge Lamorena stated a proposal was made to move ED Hattori from the Executive Pay Plan to the Attorney Pay Plan effective January to December 2024, bringing him to Attorney 5 Step 10, in line with salary adjustments. Trustee Terlaje asked for clarification that ED Hattori will remain on the EPP in an unclassified position, but will utilize the APP for salary calculation purposes. She continued that ED Hattori's pay be modified effective January 1, 2025 without retroactive pay. Presiding Judge Lamorena stated that ED Hattori will remain unclassified and be moved to the APP at Level 5 Step 10.

Motion to move Executive Director Hattori from the Executive Pay Plan to the Attorney Pay Plan at Attorney 5 Step 10, without retroactive pay, on the condition he remain an unclassified employee made by Trustee Terlaje and seconded by Trustee Quinata. Approved by acclamation.

F. SIXTH AMENDMENT CENTER PROJECTS

This matter was tabled to the next meeting.

G. CIVIL MORATORIUM – FINAL RESOLUTION

Motion to adopt the Resolution regarding the lifting of the civil moratorium as amended, made by Trustee Terlaje and approved by acclamation.

VII. **NEW BUSINESS**

A. DONATED LEAVE BANK POLICY AND RESOLUTION

Acting AD Call stated the Resolution has been amended, as requested at the last meeting. Presiding Judge Lamorena asked that a further amendment to only have the ED or MA make the final approval be made.

Motion to approve the Dontated Leave Bank Policy and adopt the Resolution as amended made by Trustee Quinata and seconded by Trustee Terlaje. Approved by acclamation.

B. ABOVE-STEP RECRUITMENT FOR ADMINISTRATIVE DIRECTOR

ED Hattori stated that Shane Ngata has been selected as AD and above-step recruitment on the General Pay Plan at Step S-10 is requested due to his extensive background. Presiding Judge Lamorean asked that the Resolution be amended to use lapse funds for this request.

Motion to approve above-step recruitment for Shane Ngata as Administrative Director at GPP S-10, \$119,633 per annum, using lapse funds, made by Trsutee Quinata and seconded by Trustee Whitman. Approved by acclamation.

C. ABOVE-STEP RECRUITMENT FOR ATTORNEY IV AT CLC

ED Hattori stated that Attorney Dominic Terlaje is currently employed at CLC in a limited term position under EJC and TAC grants. This Resolution seeks to slot Attorney Terlaje at APP Level 4 Step 9 at \$138,199.24 per annum in a permanent position.

Motion to approve above-step recruitment for Dominic Terlaje as Attorney 4 at APP Step 9, \$138,199.24 per annum, made by Trustee Terlaje and seconded by Trustee Quinata. Approved by acclamation.

Trustee Terlaje clarified that she is not closely related to Attorney Terlaje.

VIII. PUBLIC DISUCSSION



Donated Leave Bank Policy FY2025

Purpose:

The purpose of the Donated Leave Bank (DLB) policy is to provide guidance on who is eligible to donate and whom can avail of leave hours donated by a Public Defender Service Corporation (PDSC), APD, & CLC employees upon separation or retirement from employment, or in the event the Donor has excess Annual or Sick leave hours at the end of a fiscal year and decides to donate to the DLB.

Eligibility:

Donor:

Employees who have accumulated excess Annual or Sick leave hours at the end of a fiscal year and are willing to transfer such excess to the DLB;

Employees with accrued sick leave balances who are separating/retiring from PDSC, APD,

& CLC;

Employees who are retiring with hours not creditable toward retirement service determined

by the Retirement Fund;

Recipient:

An employee experiencing a medical health condition, or a personal situation and has

exhausted his/her leave options.

Policy:

This policy is developed through legal research and guidance from the Judiciary of Guam Personnel Rules & Regulations 11.1405 Donated Leave Bank. PDSC therefore request approval via Resolution from the PDSC Board of Trustees

12 GCA §11110 Employment.

(a) Pursuant to the provisions of 4 GCA § 4105 the Board shall establish rules and regulations governing selection, promotion, performance evaluation, demotion, suspension and other disciplinary action for the employees of the Corporation.

Thus the Board of Trustees of the Public Defender Service Corporation can develop personnel rules pursuant to 4 GCA §4105. The By-Laws of the Corporation further authorizes the Board "To adopt policy and rules for the operation of the PDSC, including but not limited to, personnel, procurement, facilities and property, financial and travel (the provisions of §§6302(c),6303 and 4105 of Title 4 of the Guam Code Annotated and 5 GCA §23109 of the Guam Code Annotated having been reaffirmed). Reference: (By-Laws PDSC Board of Trustees. Article 4, 4.01 d.)

The Donated Leave Bank shall be made available only to employees for the sole purpose of medical health conditions, or personal reasons/situations. Requests for hours from the Donated Leave Bank for personal reasons are permitted as defined herein.

Employees applying for the Donated Leave Bank Program shall be subject to the policies and procedures defined in the Government of Guam Leave Sharing Program in 4 GCA CH4 §4109.2.

Recipients are limited to eighty (80) hours per fiscal year per. However, a special request & approval for more leave hours not to exceed eighty (80) hours may be considered for the fiscal year.

Should the Donor return to PDSC employment, any un-donated sick leave shall be returned to the Donor as stated in 4 GCA §4108 (g) Vesting. "Sick leave accrued and unused at the time of separation from the government shall remain credited to the employee if such employee returns to government service."

Any donated leave hours transferred to Recipient but not used, shall be credited back to the leave bank within two (2) pay periods upon Recipient's return to work duty.

The HR department &/or the Fiscal department shall certify the availability of hours in the Donated Leave Bank.

Request Forms shall be entertained in order of submission for approval and processing. In the event there are two (2) or more employees requesting hours from the leave bank that exhaust its balance, the distribution of hours shall be determined by the Executive Director, using a proportional method.

Managers/Supervisors may solicit/request for leave donation through memorandum to the Executive Director on behalf of their employees who are eligible to receive donated leave for a medical health condition when the employee cannot make such request.

Divisions/Managers soliciting leave on behalf of their employees shall also verify with the Fiscal & Human Resources (HR) office as to the availability of leave in the Donated Leave Bank prior to a request.

Employees/Donors shall complete and submit a "Donated Leave Bank" form upon separation or retirement from service. (Attached)

Employees/Recipients shall complete and submit a "Request for Leave from the Donated Leave Bank" form, and any required documents to HR for review and clearance. (Attached)

Upon approval by the Executive Director or (Managing Attorneys for APD&CLC), HR will process the request and afford donated leave accordingly.

Review and Update:

This policy shall be reviewed periodically to ensure its effectiveness and compliance with applicable laws. All necessary updates will be communicated to all employees.

Definitions:

For the purposes of this policy, the following definitions apply:

- 1. Employee a person who is currently employed by Public Defender Service Corporation, Alternate Public Defender or Civil Law Center, occupying a full time position.
- 2. Donor an employee who voluntarily donates accrued excess leave hours to the Donated Leave Bank by signing the donated leave form as certified and approved by the Fiscal, HR and Directors' office.
- 3. Recipient an employee who is eligible to receive donated leave hours from the DLB, as applicable.
- 4. Excess Leave shall mean excess Annual or Sick leave at the end of a Fiscal Year or at the end of employment.
- 5. Medical Health Reasons a medical condition of an employee or an immediate family member that requires the employee's absence from work for a period of time. Medical reasons as defined in the use of sick leave shall apply.
- 6. Personal Reasons reasons not defined as Medical Health Reasons, for example; adoption of a child, divorce or separation, loss of a family member, child care, legal commitments, education for employment enrichment, temporary care of an elderly or physically/mentally disabled member of the immediate family, and other reasons as determined by the Executive or Administrative Director.
- 7. Immediate Family Defined in 4 GCA §4108 (c) (2) (B): Immediate family member means the employee's spouse, common law, parents, parents-in-law, grandparents, brothers, sisters, children, grandchildren, any step or adoptive parents, adopted children or grandchildren of both the employee and the spouse, a guardian or person in loco parentis.

Acknowledgement:

All employees are encouraged to read, understand, and acknowledge this policy. Failure to comply with the provisions outlined in this policy may result in disqualification from the DLB benefit.
